Subject:- Grant of recognition to the school from class Ist to 8th (without aid) with effect from the academic session 1994-95 for a day school.

Sir,

With reference to your application on the subject cited above, I am directed to convey the approval of the appropriate authority for grant of recognition in respect of your school from Ist to viii th (without aid) with effect from 1994-95 session subject to the fulfilment of the following terms and conditions:-

1. That the school shall abide by the provisions of Delhi School Education Act and Rules, 1973 and the instructions issued from time to time.
2. That the school shall appoint full time qualified and eligible staff as per the norms of the department. That the school shall dispense with the services of unqualified and overaged staff, if any, immediately.
3. That all the facilities prescribed under Rules 50 & 51 of D.S.E.R., 73 shall be made available to the students. Provisions of Rules 6, 7 & 8 be strictly observed.
4. That a proper library shall be established and facilities for reading room shall also be made available for students as well as teachers. Books as per the ratio of 10 books per student may be added and facilities of reading room may also be provided immediately and more books worth Rs.5000/- be purchased by the start of the next session and the list of books are furnished to the Education officer for verification.
5. Adequate sports material shall be purchased and made available to the students immediately.
6. That the school shall equip the Science Lab. as per the norms of the department and suitable facilities for practical work shall be provided to the students. More material worth Rs.5000/- shall be purchased during the current session and a list be furnished to the Education officer for verification.
7. That the school shall admit student without any discrimination of caste and creed as per the norms of the Deptt.
8. The payment shall be made as per provisions of section 10(1) of D.S.E.A., 73 to all employees. The staff should be paid full salary with allowances through cross cheque before 7th of every month.
9. That the Management of the school shall create a Reserve Fund equal to minimum three months salary of the staff in the joint name of the Director of Education and the Manager of the school.

10. that the arrangement of good drinking water shall be made available to all the students/teachers and sanitary facilities shall also be provided to the students immediately.
11. Fresh Health certificate may also be obtained from M.C.D. within a month and submitted to the Education officer for verification.
12. That the enrolment in each section shall not exceed the number of students calculated @ 10 sq.ft. per student for the available floor area of the class room and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education, Delhi, in each class. Number of the existing sections should not exceed the number of class rooms of proper size in the school.
13. That Govt. Nominee in the Managing Committee will be asked immediately and all decisions will be taken in accordance with the provisions in the approved Scheme of Management by the D.D.E. (Act).
14. The Managing Committee of the school shall not enhance the fee during the ensuing academic session without the prior approval of the Director of Education which is a mandatory requirement under sub-section (3) of Section 17 of Delhi School Education Act, 1973 and shall regulate the functioning of the school strictly in accordance with the provisions of the Act and Rules.
15. IXth class should not be started without the prior approval of the Director of Education.
16. That the violation of any instructions/orders/conditions/rules and regulations of the department shall lead to the withdrawal of recognition of the school.
17. That a report about the fulfilment of the above conditions giving the extent to which each condition is fulfilled shall be sent to the Education Officer within six months.

Sir,

With reference to your application on the subject cited above, I am directed to convey the approval of the Director of Education, Delhi for grant of up-gradation upto Sr. Secondary level (without aid) with effect from the academic session 2010-11 in Arts and commerce stream under Rule 52 & 53 of DSEA&R 1973 & Right to Education Act-2009 subject to the following terms and conditions.

1. That the school shall abide by the provisions of Delhi School Education Act, 1973 and Rules framed there under as well as the instructions issued from time to time by the Department.

3. That the school shall meet the additional liability of senior secondary classes along with additional class rooms for class -XI & XII.

5. That a proper library shall be established and facilities for reading room shall also be made available for students.
6. That an adequate sports material shall be purchased and made available to the students.
7. That the school shall strictly abide by the provision of section 10(I) (A) of the Delhi School Education Act/Rules 1973.
8. That the school shall not run any un-recognized class or any non-educational activities within the school premises and all the recognized classes shall be run at one place at the above address only. Nursery classes be removed from the premises of the school immediately, if any.
9. That the school shall dispense with the services of unqualified and over-aged staff, if any, immediately.
10. School shall provide fee structure of coming session by 31st March of every year.
11. That proper facilities for drinking water, toilets and first aid be provided, separate toilets for boys, girls and separate toilets for ladies and gents staff are also provided.
12. That the Managing Committee of school shall not increase/enhance fee during the ensuing academic session without prior approval of the Director of Education which is mandatory requirement under sub section (3) of Section 17 of Delhi School Education Act & Rules 1973.
13. That the school will apply for P.F facilities to the Provident Fund Commissioner and will provide the same to the staff in proper manner.
14. That all the facilities prescribed under Rule 50 & 51 of the Delhi School Education Act & Rules 1973 shall be made available to the students.



15. That the Management of the school shall create a Reserve Fund equal to the minimum of Rs. Two lacs plus Rs. 80/- per student in the joint name of the Directorate of Education and the Manager of the School.
16. That the school shall comply with the norms of the CBSE for affiliation for examination purposes.
17. The school should provide P.F., LTC, Medical facilities to the staff as per DSEAR.
18. The school will apply for nominee of DE/Advisory Board to the Act Branch of Dte. of Education.
19. That the school shall abide by the Public Notice dated 4/5/1997 and order no. DE.15/Act/Duggal.com/203/99/23033-23980 dated 15.12.99 issued by the Directorate of Education.
20. That the school abides by the circulars/instructions issued by the department regarding EWS/admission under any other scheme notified from time to time.
21. The Management will appoint the adequate number of teachers and other employees as per existing Recruitment Rules. The teacher/pupil ratio should not exceed 1: 30 for primary classes & 1:35 in upper Primary Classes.
22. The School will abide by the provision of RTE Act 2009.
23. The management of the school shall ensure that the Payment of salary and other allowances as per Govt. norms (as per recommendation of 6th pay Commission). An affidavit may be submitted to the undersigned within 15 days from the date of issue of this letter


